**Sub: Declaration of Combined Administrative Services Examination (CSIR CASE -2023)
Stage-I result for recruitment of SOs and ASOs – reg.**

This is for information of all candidates who appeared in the Stage-I Examination (Paper I and Paper II) of CSIR CASE -2023 held from 05.02.2024 to 20.02.2024 that result of Stage-I Examination is available on the 'Online Recruitment Portal', as per details given below:-

1. The Raw Score, Percentile Score and Normalized Score obtained by the candidates can be viewed/ downloaded/ printed by using the portal <https://csir.cbtxampportal.in/> after entering the required credentials (i.e. Registered Email, Date of Birth, Mobile OTP etc.) by the candidates. **The portal will remain live during the period from 03.06.2024 (11:00 hrs) to 18.06.2024 (17:00 hrs).** The step by step process required to be followed to download the result is also available at the above mentioned link.
2. The 'Challenges' received through 'Challenge Management Portal' have been processed as under :-
 - i) **If Questions or Options are found Invalid** (No Mark to any candidate)– If questions or options have been finally considered to be invalid (i.e. either the question is not valid or all the four options given in the question are not found valid), no mark has been awarded to any candidate. Such question(s) has/have been treated to be withdrawn/deleted. In such circumstances, marks have been recalculated keeping the total marks of Paper I as 150 and of Paper II as 200. The above scenario is explained with the following illustration:-

No. of Questions in a paper: 150, Questions withdrawn/ deleted in a particular shift: 02, Score of a candidate: 90 marks.

The final mark for the candidate has been recalculated using the formula:
*Final Mark = {Total Questions / (Total Questions - Number of Questions withdrawn)} * Candidate's Mark*
*= (150 / (150 - 2)) * 90*
= 91.21
 - ii) **Correct Option is found Invalid in Provisional Answer Key (Answer Key Change):** If the correct option listed in the provisional answer key has been found to be invalid (e.g. any typing error occurred in making the answer key), the correct option has been updated in the final answer key.
 - iii) **More Than one option is found Correct:** In case where more than one options have been found correct, marks have been given to all the candidates who have marked any of the correct options.
3. The result has been prepared based on verified Final Answer Keys, after resolution of all the 'Challenges' received through 'Challenge Management Portal'.
4. The candidates can view and download/print the Questions and correct Answers, on the same online portal i.e. <https://csir.cbtxampportal.in/> The step by step process required to be followed is also available at the above mentioned link.
5. The Normalization of Scores has been done in accordance with Normalization method/formula notified vide CSIR Notice No. 3-2(a)/2023-E.I (RC) dated 13.02.2024.
6. The candidature of the candidates having multiple attendance/ appearances in the Stage-I (CBT) Examination stand cancelled by invoking the provisions of clause 11(f) of the advertisement.

7. No individual candidate will be informed about the Scores obtained separately through any other mode. However, notification containing details about downloading of Admit Card having venues of examinations will be issued separately and necessary email and SMS alert will be sent on their registered email ID and mobile number.
8. No further query with regard to final answer key(s) will be entertained.
9. The details of the shortlisting criteria used for finalizing the list of provisionally shortlisted candidates for appearing in Stage-II Examination of CASE-2023 (Paper-III and the Computer Proficiency Test-CPT), venue for Stage-II examination, category wise minimum cut-off marks out of 350 in Stage-I etc. are attached herewith as Annexure-I.
10. **The Stage-II Examination (Paper-III and CPT) of CSIR CASE-2023 will be held on 7th July, 2024 (Sunday).** The Paper-III (Descriptive Exam) will be conducted in the morning shift and CPT (for the post of ASO only) will be conducted in the afternoon shift at the same examination venue. Notification containing details about downloading of Admit Card having venues of examination will be issued subsequently.
11. The list of candidates provisionally shortlisted for Stage-II Examination of CSIR CASE-2023 is available on CSIR website and can be seen on the link <https://www.csir.res.in/case-career-opportunities/recruitment>. The list is provisional, pending scrutiny of eligibility as mentioned in the Advertisement No: E-I/RC/2023/1 for the posts of SO and/or ASO. In case, it is found at any stage of selection that the candidate does not fulfil the eligibility criteria and any information provided by the candidate is found to be false or is not in conformity with the eligibility criteria mentioned in the advertisement including Age, Reservation Category, Application Fee, Educational Qualification, etc. or found ineligible on other grounds the candidature of such a candidate will be rejected at any stage of selection process and even after appointment.
12. Candidates are requested to follow the CSIR website i.e. <https://www.csir.res.in/> for the updates, as all the subsequent information / notification / corrigendum / addendum regarding this recruitment process will be hosted on the CSIR website only.
